Message From the Director

It’s spring—so the Alabama Legislature must be in session!

This year’s session should prove very interesting as various stakeholders try to access a shrinking pool of funds. The American Recovery and Reinvestment of 2009 has been signed into law, possibly bringing special relief to some of the programs that support individuals with disabilities and their families. Some of those include: funding to K-12 special education; preschool special education funding; early intervention funding; adjustment to state % of Medicaid funding; rehabilitation funding and others.

However, advocates for individuals with developmental disabilities must maintain a close eye on Montgomery as much of the funding from Washington does not

prohibit states from shifting existing funds to make up shortfalls elsewhere. This could leave programs still under-funded.

There is also continuing work toward a comprehensive system for individuals with autism and their families. A statewide coordinator position will soon be filled and other issues are being resolved.

Waiting List Crisis

Waiting lists for services across the United States for individuals with Intellectual and developmental disabilities and their family members have reached critical levels.

Medicaid provides the majority of funding for the programs and services for people with developmental disabilities, including Home and Community-Based Services such as supported living, supported employment and other services (as well as Day Habilitation in Alabama). Each state has the discretion to decide what services they will offer, how many people waivers will serve, and how much funding they will allocate. As the economy has worsened, often the first cuts in budgets are services such as those provided to individuals with intellectual and developmental disabilities.

The Arc of The United States is firmly committed to addressing the waiting list crisis that adversely impacts the lives of the 7.2 million Americans with intellectual and developmental disabilities. The Arc is dedicating its efforts to educating and informing a wide audience on the inequities of the waiting list system from state to state. For more information, visit www.thearc.org.

In the State of Alabama, the waiting list has now climbed to over 1900 individuals. Due to budget restraints, no new services are being provided in 2008 except those deemed as critical.
